Croton Council on the Arts – Membership & Donation Form

As a member of the Croton Council on the Arts, you can log in to your member account where you can renew online, see your membership status, and add to your personal information. To log in for the first time, go to <http://www.crotonarts.org>, click on "Login" (upper right), click "Get help" for "Lost your Password?", type in your email address, and set your username and password.

Your renewal date will be a year from the date you join. (If you are currently a paid-up member, and renew, your renewed membership will not actually start until your current membership year ends.)

(Note: The online automatic renewal option is *not* currently available. You will receive an email renewal reminder in advance of the end of your membership year.).

If you select Gallery privileges for the first time, setting up your Gallery account will take several days –you will then be sent an email with instructions.
